Women We Should Know About: Kizzmekia S. Corbett

Kizzmekia S. Corbett, well known for her work on the mRNA vaccines used to protect against Covid-19, has been named the recipient of the 2021 E.E. Just Award by the American Society for Cell Biology (ACSB).



Corbett is currently an assistant professor in the Department of Immunology and Infectious Diseases at the Harvard T. H. Chan School of Public Health. She is also the Shutzer Assistant Professor at Harvard's Radcliff Institute of Advanced Study and an associate member of the Phillip T. and Susan M. Ragon Institute.

The E.E. Just Award honors early 20th century biologist Ernest Everett Just, who made groundbreaking contributions to cell and developmental biology. It recognizes the outstanding scientific achievements of a U.S. researcher belonging to a historically excluded racial or ethnic group, and the awardee is selected by the ASCB Minorities Affairs Committee.

"I am honored to receive the E.E. Just Lecturer Award for my contributions to COVID-19 vaccine development," Corbett wrote to ASCB. "Above my contributions to COVID-19 vaccine development, it's an honor to be recognized among the ranks of a long list of accomplished peers who have received this award previously and who will in the future."

Corbett earned her BS in Biological Sciences with a secondary major in Sociology in 2008 from the University of Maryland, Baltimore County, where she was part of the elite Robert and Jane Meyerhoff Scholars Program, as well as a National Institutes of Health undergraduate scholar. She then earned her PhD in Microbiology and Immunology in 2014 from the University of North Carolina at Chapel Hill, where she received the Director's Scholarship and the Doctoral Merit Award.

Prior to Harvard, Corbett was a research fellow and scientific lead for the Coronavirus Vaccines and Immunopathogenesis Team at the National Institute of Allergy and

Infectious Diseases Vaccine Research Center. Her expertise in viral immunology propelled the development of novel vaccines for pandemic preparedness, including mRNA-1273, a leading vaccine against SARS-CoV-2. The vaccine concept—which incorporated mRNA-1273— was designed by Corbett’s National Institutes of Health team from viral sequence and rapidly deployed to industry partner, Moderna, Inc., for Phase 1 clinical trials, which began only 66 days from the release of the viral sequence—an unprecedented feat.

The mRNA-1273 vaccine was shown to be 94.1% effective in Phase 3 trials and was authorized for use in multiple countries. Alongside mRNA-1273, Corbett boasts a patent portfolio that includes universal coronavirus and influenza vaccine concepts and novel therapeutic antibodies. In all, she has over 15 years of experience studying dengue virus, respiratory syncytial virus, influenza virus, and coronaviruses, garnering her several prestigious awards, such as the Benjamin Franklin Next Gen Award and the Salzman Memorial Award in Virology.

Corbett will continue this type of research in her new role at Harvard. According to a news release from the institution, “Corbett will head the new Coronaviruses & Other Relevant Emerging Infectious Diseases (CoreID) Lab to study and understand the interface between hosts’ immune systems and viruses that cause respiratory disease, with the goal of informing development of novel and potentially universal vaccines.” Combining her research goals with her knack for mentorship, Corbett also invests much of her time in underserved communities as an advocate of STEM education and vaccine awareness.

How White Feminism Threw Its Black Counterpart Under the Bus



Here are two salient touchstones: Hillary Clinton's defeat in the 2016 presidential election, significantly abetted by the approximately [50 percent](#) of white women who cast their ballots for Donald Trump; and the U.S. Supreme Court's refusal, in September, to block the Texas law that bans abortions after six weeks of pregnancy. Sixty-five percent of white women in Texas voted for Gov. Greg Abbott, and 60 percent for Senator Ted Cruz, both vocal supporters of that law. After both incidents, Black feminists found our timelines and inboxes flooded with a deluge of white feminist shock and tears accompanied by a familiar, exhausting ask: *How could we have let this happen?*

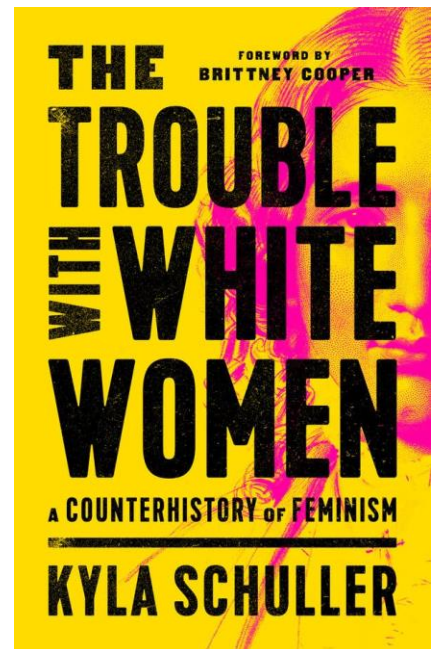

POLICIES AND PROCEDURES
September 2018

Decisions affecting the operation of the Board of Directors and its work are called Policies and Procedures. They are adopted or changed by a vote of the board. A policy is an interpretation of decisions made by the branch board over time. A procedure describes the steps that need to be taken to carry out the policy.

Fallbrook Branch policies, procedures, and standing rules shall be reviewed every 2 years or as needed.

I. DUTIES OF OFFICERS

A. The President shall:

1. Serve as administrator, coordinator, and creative planner for the branch.
2. Preside at all meetings of the branch Board of Directors.
3. Oversee the submission of such reports and forms required by AAUW and the state.
4. Represent the branch at the Inter Branch Council Meetings.
5. Serve as an ex-officio member of all committees and task forces except the nominating committee.
6. Call special meetings of the board in accordance with provisions of the branch bylaws.
7. Appoint the chairs of all task forces and committees except the nominating committee and those provided for by election and any additional officers authorized by the branch bylaws.
8. Receive all written requests for dues assistance and together with the Board decide amounts of award.
9. Monitor website and Gmail account for correspondence and funnel to appropriate chair
10. Send or delegate to Tech trek Chair donation requests and thank you letters for funds received.

B. The Program 1st Vice President shall:

1. Lead the development of the annual program schedule to include topics relevant to the AAUW mission.
2. Serve as chair of the program committee.
3. Preside at meetings in the absence or inability of the president to serve.
4. Send out program invitations to membership and coordinate monthly meeting details

C. The Membership 2nd Vice president shall:

1. Lead new member recruitment strategy and chair membership committee.
 2. Preside at meetings in the absence of the president and first vice president.
 3. Work with membership committee to engage new members in branch activities
 4. Update membership directory annually
 5. Coordinate distribution of recruitment flyers around town
 6. Give AAUW presentations to local groups
- D. The AAUW Funds 3rd Vice President shall:
1. Serve as chair of the AAUW Funds Committee and lead the development of programs to raise funds for the branch and AAUW Funds.
 2. Coordinate committee to execute fundraiser events.
 3. Select a speaker for said Fund Raiser (if applicable).
 4. Create an archive of previous programs
- E. The Recording Secretary shall:
1. Have available for reference at all meetings a copy of the branch bylaws, Policies and Procedures and a list of officers, task forces, committee chairs and members.
 2. Send notices, agendas, and minutes to board members regarding forthcoming board meetings.
 3. Take minutes at monthly board meetings and send them to board for approval. Once approved, send minutes to membership.
- F. The Corresponding Secretary shall:
1. Send thank-you letters as designated by the board and appropriate committee chairpersons, keep the board informed of members experiencing personal troubles and send letters of care and concern to the members.
- G. The Treasurer shall:
1. Be knowledgeable on basic financial requirements and accounting terms, including budgeting and planning. Be comfortable with Excel or QuickBooks
 2. Receive all monies due the branch, state and national.
 3. Maintain and manage bank accounts (checking, savings, two Legacy accounts)
 4. Submit monthly reports to board of directors.
 5. Track expense reimbursements and provide reimbursements within 2 weeks
 6. Pay all bills provided for in the budget or verified by the president.
 7. Request insurance coverage forms one week prior to events in public places

8. Electronically file IRS Form 990-N if gross receipts are \$50,000 or less via national filing
9. Electronically file the CA Franchise Tax Board Form if gross income is \$50,000 or less via e-postcard
10. Electronically file the CA Attorney General Form RRF-1. If gross annual revenue is less than \$25,000 the fee is \$0. If gross annual revenue is between \$25,000 and \$100,000, the fee is \$25.
11. Send membership dues via MMP; track membership
12. Keep financial notebooks (electronic and hard copy) up to date for audit purposes
13. Submit and track donations checks to appropriate funds (AAUW National, Legacy, Tech Trek and local).
14. Submit Tech Trek forms to state (both hard copy and via email); track donations.
15. Check mailbox weekly
16. Scholarships: ensure correct information and proof of enrollment is obtained from all recipients and request checks from Legacy
17. Send out membership renewals 3-5 times per year during renewal season (about once per month from May-Oct).

II. STANDING COMMITTEES

- A. The AAUW Funds Committee shall be responsible for implementing the Funds programs on fellowship research and projects as may be established by the State Funds Director and/or the Association.
 1. All donations to Funds under the auspices of the Educational Foundation, such as the Educational Endowment Fund, Legal Advocacy Fund and California Association Tech Trek Fund, etc. shall qualify for tax advantages under the IRS 501(C) 3 guidelines for nonprofit organizations.
 2. The committee shall include, but not be limited to the AAUW Funds and Tech Trek chairs, members who chair events such as Mah Jong tournaments for the benefit of the AAUW Funds and two additional members.
 3. There shall be multiple Funds events, the programs for which shall include an appropriate Funds speaker (if applicable) or other activities.
- B. The Public Policy Committee shall be responsible for the public policy program. The Public Policy Chair may write letters on Fallbrook Branch letterhead or send emails/Action Alerts within the scope of the public policy program and clearly in accord with previous study and action of the Fallbrook Branch. Such correspondence must be submitted for review and approval to

the President and task force chair in whose area the measures fall before they are sent.

Action for the Public Policy Committee to consider through questionnaires to the membership: The public policy chair and committee can search out and recommend names of women qualified for public service. These names will be presented for discussion by the Public Policy Chair to the general membership before any endorsement is made on behalf of the Fallbrook Branch.

- C. The Membership Committee chaired by the Membership Vice President shall be responsible for the branch membership recruitment and orientation to the purpose and program of the Association.
- D. The Program Development Committee:
 - 1. Chaired by the Program Vice President, may include such members as deemed necessary.
 - 2. Shall consider the public policy platform issues or mission-based programs of the Association and shall recommend to the branch the selection of programs to be implemented. It shall provide policy guidance for the continuing program concerns of the branch and shall also consider future mission-based programs of the Association.
- E. The Scholarship Committee shall:
 - 1. Be responsible for reviewing all scholarship grants. It shall establish appropriate guidelines and qualifications for the various grants under its jurisdiction and communicate these guidelines to Legacy Endowment, the Community Foundation. While Legacy Endowment, the Community Foundation, will be responsible for distributing funds to the recipients when terms of the grant require it, the scholarship committee will be responsible for choosing the said recipients.
 - 2. The Fallbrook AAUW Branch shall provide for Tech Trek scholarships, Fallbrook Union High School District scholarships, and Continuing Education scholarships for women and girls according to available funding.
 - 3. The funding shall come from the amount budgeted from annual fundraisers and donations.
- F. There shall be such additional Standing Committees as deemed necessary by the Board of Directors.

III. FINANCES

- A. Branch chairs will keep receipts and records of expenses incurred by the committees and will stay within the amounts budgeted by the board. Such receipts and records will be turned over to the Treasurer in their entirety at the end of the branch fiscal year or sooner.
- B. Reimbursements to branch chairs & their committee members during the fiscal year will be made upon the submission of a voucher to the branch treasurer within a month of the expenditure.
- C. No expenses in excess of budgeted amounts will be honored unless pre-approved.
